Dear Mr. Adler:

I write this letter with respect to the above crimes inflicted on me while bringing over 200 thousand readers to Scribd via my writing. I am repulsed with the unregulated lawless practices inflicted on me. Please see the summary below.

Please read the below emails summarizing the crimes inflicted on me by employees of Scribd.com, acting as hit men. My account was deleted criminally, lawlessly, negligently, maliciously, and enviously. I have tried to resolve this problem via several emails. I have had no success while I am being harmed by this Cyber tort.

My professional online reputation has been maliciously tampered with by this malicious, lawless, and envious account deletion. There is no reason for this fraud and malice.

I seek immediate accessibility to my Scribd Prayer Warrior account to retrieve my work to minimize further harm. I published legal documents, affidavits with US Mail receipts. These documents are needed. I had no idea Scribd would operate as a criminal enterprise and attack the very writers that make Scribd a success. I was unprepared for these crimes and I pray that you stop them from happening to other people.

I need accessibility to my legal documents posted on Scribd. I was never notified of the deletion prior to the deletion. The lack of notification, coupled with criminal fraud allegations, disguised as reasons for this treatment, exemplifies criminal insanity management.

Your lower level employees, as exemplified in the below emails, are being criminally used to cyber stalk and cyber bully. The ramifications of such are deadly and costly. I urge you to stop these criminal practices on behalf of public policy and safety.



My name is Miriam Snyder. I write this email to document the criminal use of the internet to silence unregulated crimes, murders and attempted murders. See the criminally deleted links below, starting at page 25.

Foremost, I am an educator and human rights advocate. I am a crime victim being set up to be killed under the disguise of legal abuse syndrome and eugenics. My sister and father were recently killed under these tactics. I am using the internet to post affidavits with the US mail receipts to document and expose these killings and crimes. My family is being killed and attempted murders are inflicted in every capacity of my life. One of my means of survival was via the use of the affidavit process and internet publishing. I have never written anything non verifiable. All of my writings were in good faith, on behalf of public safety, public interest, and public policy.

Recently, after taping elder abuse inflicted on my mother, I am being cyber bullied and harassed. My talkshoe.com and Scribd.com sites with most of my evidence were both deleted without notice, or verifiable cause or reason.

I have volunteered over 5 years on these sites. See below. All of my work on these sites are being maliciously deleted under repetitious non verifiable fraud, disguised as alleged violation of term agreements. After five years of exemplary work, out of nowhere this fraud based non verifiable phenomenon is being used to sabotage, shut my work down, and attempt to harm my professional reputation. . Needed and sent out criminal reports are being disabled from being read under this criminal phenomenon.

Now I am being stalked. First it started with Talkshoe.com, now the same fraud is happening at SCRIBD.com. I have tried to correct the problem through management. Yet, I still suffer the ramifications of this cyber bullying and stalking. Below are my two summarized complaints. I am in the process of writing affidavits documenting these crimes. I would like to know what can I do to immediately stop these cyber bullying, stalking, malice and fraud based crimes, with intent to silence the documenting of crimes involved in the conspiracy to murder my family and I. Please see the below linked affidavits, that have been criminally deleted.

Please note that since both websites are using the same criminal tactics of not notifying me of the deletions and disablements prior to such, my intellectual property rights, my work, is being criminally withheld from me. Dear Scribd Supervisor:

I received the below erroneous and malicious email from a Scribd worker named Jason. I seek correction. I believe selected Scribd workers are being paid or recruited to maliciously attack targeted writers work in the furtherance of a documented conspiracy against rights of we the people. I say this because this is the second Scribd worker attack on my account based on fraud.

Last week I received a fraudulent email from a Scribd worker named Alex. I sold over a hundred dollars' worth of work on Scribd. After reaching the one hundred dollar mark, my dates and numbers were manipulated.

Thereafter, I criminally received an email from Alex stating that I had not met the 100 dollar threshold when prior to December 31, I was over 100 dollars. After I received his email, my sales numbers and dates changed. This is called organized crime. Someone in Scribd noted the crimes and corrected the matter before escalation.

This week, out of nowhere, I am again facing another Scribd worker, Jason, fraudulent attack on my work via the malicious deletion of my account based on fraud and deception.

He alleged that my account was in violation of things that do not exist. Please see his below non validated and malicious allegations.

Foremost, pursuant to his non verifiable allegations, I have never published any personal information about others with or without their consent. All of my goodwill work comes from and is researched information taken from the public domain. I have never used anyone's home address in my documents without his/her consent. I have used publicly posted email addresses, phone numbers and business addresses. My documents, for the most part are in legal form. Most of my documents are public interest, public policy, and public safety affidavits.

I have never received any complaints about my account or my work as I specialize in fighting for human rights and I do not believe that any verifiable complaint exists. I believe that someone is using Jason to silence well and professionally documented crimes, attempted murders and murders.

My account was criminally deleted without any notice and or verifiable cause. In addition, the lack of notice and an opportunity to be heard is inhumane. These tactics maliciously harm one's reputation and dissolves goodwill human rights work.

All of the work I have on Scribd is in the public interest. Jason's allegations have nothing to do with my account.

To this end, I am asking that a supervisor intervenes in this matter in stopping this unwarranted, non- verifiable and malicious assault on my work and documents. I would like my account reinstated and to be treated like any other human being would want to be treated, particularly one fighting and writing on behalf of the public interest.

Above all, my over 250,000 readers and commendations of my work on Scribd outweighs any and all unwarranted and alleged complaints.

If complaints exist, how does Scribd know such is not coming from perpetrators of crimes seeking to silence the use of affidavit writing for exposing crimes?

Please stop the replicated internal Scribd worker harassment. Mandate equal treatment, verification of allegations, notice of any and all alleged violations, with an opportunity to be heard. Stop the use of alleged multiple violations when not one alleged violation was told to the writer.

Treat writers the way anyone reading this would want to be treated. Stop the use of Scribd workers to attempt to silence unregulated crimes and killings.

Develop a policy that respects and compensates writers contributions to Scribd. Do not treat writers like I have been treated. My account was criminally disabled without my consent, approval, authorization, without notice, cause or reason. No human being should be treated like this, particularly after I have drawn almost a quarter million of readers to Scribd.

Please resurrect my account on behalf of goodwill, public safety, public interest, public policy, righteousness, non validated allegations that do not outweigh the commendations , contributions, and audience I have brought to Scribd.

Please stop Jason and Alex from being a liability to Scribd, acting as hit men, harming and conspiring to harm targeted writers. Please stop Jason from obstructing the First Amendment free speech right.

My professional reputation is being tampered with maliciously. Please stop this. Investigate Jason and Alex's unwarranted harassment inflictions under the disguise of working for Scribd.

Please make Jason produce the alleged published documents with personal information about others without their permission or consent, including the alleged many documents containing unredacted email addresses, phone numbers, and home addresses.



Dear Ms. Ennis:

I write this letter with respect to the alleged excessive, erroneous, malicious, and unwarranted violations in the attached letter. Foremost, I am a senior citizen who respects, appreciates, and needs Access- A- Ride. In addition, I am disabled. I would never violate Access-A-Ride services to the level to warrant suspension as I am a responsible and appreciative customer.

For the record please note I have never had a NO Show. My daughter who handles all of my Access-Ride scheduling's makes all calls in front of me. We find it inconsiderate and inappropriate to simply not show and would never do such. If I was not going on a scheduled trip, a cancellation call is made. This is a priority. Please note my history. I am not one for NO Shows.

With respect to the alleged trips of November 2011, I contest all of the No Shows as exemplified in my Daughters attached affidavit and attestation.

The November 2, 2011 No Show allegation is untrue as stated in the attached affidavit. The November 15, 2011, No Show allegation is in accurate. I witnessed my daughter boarding the Access- A- Ride vehicle on November 15, 2011, offering the driver the fee and explaining to the driver that the wheelchair guest was going to be hospitalized.

My daughter explained to the driver that an emergency had occurred. The driver refused the fee and said she would report the emergency. In addition, it was explained to the driver that due to the emergency the later trip for November 15, 2011, would need to be cancelled.

In summary, I have no record of the alleged November 2, 2011 NO SHOW and I did not receive a receipt for my trip that day. The 2 trips of November 15, 2011 were cancelled because of the wheelchair guest hospitalization that we could not predict. However, we met with the driver and explained the emergency.

I ask that the late cancellations from 11/19/11 to 11/29/11 be excused due to circumstances beyond my control embedded in medical emergencies related to the hospitalization and killing of my daughter November 21, 2011.

Please note November 21, 2011 I knew I was staying in the hospital and witnessed my daughter calling and cancelling the scheduled Access-A-Ride, 3 hours before the scheduled pick up time. Please note I have two daughters.

My daughter was killed November 21, 2011 and every event that occurred after such date was not planned. We were unprepared for this and this atrocity caused much confusion. I have attached a copy of her death certificate to verify the medical emergencies and death, illustrating, circumstances beyond our control.

11/19/11 to 11/21/11 I could not leave the hospital and did not know my daughter would be killed. 11/21/11 I do recall my daughter calling Access-A-Ride 3 hours before the scheduled trip. This was the day my daughter was killed and we planned to stay in the hospital overnight. Consequently, she called in front of me 3 hours in advance.

Please note my travel history. I have no history of no shows and few late cancellations, only emergencies. Nothing I have done warrants suspension or the threat of such. I am saddened with this. I feel targeted and set up. To this end, I am asking for the methods of verifying and or validating the time of cancellation calls. I believe this loophole for human error is being used to harm and abuse me.

In closing, Access-Ride is an exemplary and needed service for the disabled and elderly. I am both and greatly need and appreciate the service. I did nothing to warrant suspension or the threat of such.

The few late cancellations incurred were due to the noted medical emergencies and death. Please note because I believe someone is using Access-A -Ride to target me, please note my husband died the month of May 2011 and that was the only other time a few late cancellations were made.

I feel the excessive violation allegations during the November 2011 killing of my daughter is exploitative.

Senior citizens should not have to keep a journal to receive equal treatment on Access-A-Ride. I have been wrongly accused of warranting a suspension when my daughter and I carefully plan trips, cancel properly and have never had any No Shows.

I pray I am not being subjected to this or retaliated against because I complained about 2 Access-A-Ride workers. Please listen to one of the complaints here:

I believe I am being harassed and at 83 years old I do not deserve this. I appreciate and use Access-A-Ride as a valuable asset and resent unwarranted threats of service at the masterminded expense of the death of a loved one.

Again, attached is the death certificate for the killing of my daughter during the alleged excessive violation time frame. The violation allegations are excessive, inaccurate, not validated, exploitative, insensitive, unwarranted and exemplifies components of elder abuse.

Please stop these inhumane practices against the elderly and disabled. I respect, admire and value Access-A-Ride services and resent this exploitation. Thank you for your time.

AFFIDAVIT IN SUPPORT OF THE ACCESS-A-RIDE APPEAL OF MAZARINE SNYDER

I Miriam Snyder am the PCA and scheduler for my mother, Mazarine Levy Snyder's Access-A-Ride services. I make all of her appointments and I do such carefully and responsibly, as this disability service is much needed in the community. As stated in her appeal affidavit, the alleged violations are erroneous, malicious, exploitative, and excessive.

My elderly mother's other daughter was killed November 2011 and the Access-A-Ride internal programmers knew such. Trips were scheduled to and from the hospital and funeral home. It is malicious and insensitive for the attached November 2011 alleged Access-A-Ride excessive, erroneous and unwarranted violation allegations, particularly during the murder of a loved one.

The November 2, 2011 alleged violation needs to be investigated because my records show that this was the trip where the driver harassed my mother as noted in her affidavit.

The two trips for November 15, 2011 were not No Shows. The first trip of November 15, 2011, I met with the driver, offered the fee, and explained that our wheelchair guest had a medical emergency that effectuated hospitalization. The later trip for November 15, 2011 may have been cancelled improperly. I asked the driver to cancel it because of the medical emergency. The medical emergency caused much havoc and we were faced with a non-expected hospitalization.

The 11/19/11 to 11/29/11 trips were cancelled. I cancelled three hours in advance for most trips. In the midst of the medical emergencies and killing of my sister the timing may have been off two or three times, not 5, and this happened due to the emergency medical circumstances noted in my mother's affidavit.

I can attest to the fact that I did cancel 3 hours in advance on 11/21/11 because this was the day my sister was killed and my mother and I were planning on sleeping in the hospital, prior to her death.

We, my mother and I, have no history of NO SHOWS. This has never happened in our entire history with Access-A-ride. We have no history of unwarranted late cancellations. Death is an ugly situation and because of such, the above incidents occurred. Access-A-Ride records are inaccurate and the alleged violations are excessive. Most of the cancellations are made 3 hours prior to the scheduled visit.

I pray my mother is not being harassed. I say this because I am saddened with the retaliatory inaccuracies in the attached letter threatening an unwarranted suspension.

I say retaliatory, because November 11, 2011 I was compelled to file a complaint regarding Access-A -Ride -Workers deliberately creating a hostile environment. Please listen to the 311 audio below.

I was so upset with the Access-A -Ride -Workers new elder abuse and harassment treatment of my mother, in desperation, I sought to file complaints on the workers.

I taped the conversation because I was sick of the Access-A-Ride harassment. In short, my mother asked for a 9PM or later pick up from the facility her sickly daughter was at. The Access-A-Rider scheduler refused to schedule my mother's pick up time after 9pm. The Access-A-Ride scheduler scheduled a pick up at 8 pm despite this time conflicting with my mother's request and visitation schedule at the facility. The below people were spoken to:

Three Access-A -Ride -Worker harassment incidents happened in the month of November 2011, in the midst of the murder of my sister. It was as if someone was paying Access-A-Ride workers to harass my mother to deter us from visiting my sister before she was killed. The incident that compelled me to call 311 regarding Access-A -Ride -Workers was the refusal of a scheduler to schedule a 9pm or after pick up.

November 11, 2011, the scheduler refused to schedule a 9pm or after pick up without reason or cause, simple harassment. The scheduler said the only pick up time for my mother was 8pm. We could not understand why a scheduler would do this, particularly while we were arriving at the location after 7pm. It was as if someone directed the workers to harass us regarding a needed pick up time after 9 pm. The scheduler refused to schedule a 9pm or later pick up and I, in good conscience and on behalf of other elderly and disabled people, I filed a 311 complaint regarding this harassment.

The scheduler violated Access-A -Ride's very own policies to harass my mother and we want to know why? Specifically, the scheduler abused my mother by telling her that she could not get an after 9 pm pick up, and said such, maliciously, arrogantly, and without cause or reason. It was as if someone ordered this harassment to minimize my mother's time to visit her sickly daughter.

Please note after filing the complaint with 311, an Access-A -Ride -supervisor was called in and corrected the problem via scheduling an after 9pm trip as requested. Please note this had never happened previously. This was covert elder abuse and if my mother did not have an advocate she would have been forced not to see her daughter because of this scheduler's harassment agenda. Again, this was unusual, most schedulers and drivers have been outstanding.

In addition to the above incident, November 2, 2011, a hostile driver picked us up at the Beach Street location noted and brought us to my mother's home address in Astoria. This driver was on a mission to harass my mother. He refused to drive next to the location where there was access for the vehicle.

He wanted my elderly mother, with her walker to walk across the street to the Access-A-Ride vehicle, when he was able to pull up next to the facility. There was no need for her to walk across the street in the snow. In addition he was rude, rough, and scandalous. He argued all the way to her house.

I did not file a complaint regarding this driver, because this was unusual. Most drivers are very nice and professional. Since it was so unusual, it was let go. But, when the above noted scheduler told us, we could not get a pick up time after 9pm, I knew someone ordered harassment, because these incidences should not have happened. I believe someone ordered the above noted harassment incidents so my mother would not visit her daughter as much as she did. In addition, I believe someone added falsified Access-A-Ride - records to maliciously create a reason to threaten needed services.

Someone is trying to harm my elderly mother and I ask that Access-A-Ride not be included. Please see the reference section. Usually this harassment is ordered from the top and is implemented internally. My mother has done nothing to warrant the suspension threat, particularly with the above facts at hand and with a dead daughter that was killed during the alleged violations time frame.

I pray that my mother will not have to tape every Access-A-Ride discussion to stop this harassment. I pray my elderly mother will not have to remind each driver to give her a receipt and hide the receipts so if this happens again she can have proof of her trip. I pray that the falsification of Access-A-Ride records to target my mother will be exposed. I pray that other elderly people are not being harassed and targeted like this. I pray that Access-A-Ride will not be used to further victimize my elderly mother regarding the death of her daughter.

The timing, medical emergencies and the death of my sister exemplify extenuating circumstances. My elderly mother has suffered greatly behind the November 21, 2011 killing of her daughter and the Access-A-Ride Flashback with inaccurate and penalizing records further injures and harms my elderly mother.

An Access-A-Ride suspension would be a disregard of justice, care for the elderly and an additional inflicted travesty on my mother. My mother would be penalized for alleged excessive violations and circumstances regarding the murder of her daughter.

In closing, for the above reasons we seek justice in the appeal and an investigation into the harassment inflicted on my elderly mother by the above linked Access-A-Ride workers. My mother has done nothing to warrant a suspension. My mother is being harassed.

I seek an end to the harassment. I seek my elderly mother to be treated the way anyone's mother would want to be treated. The suspension threat and its untimely violation allegations are unwarranted. Someone is using loopholes in Access-A-Ride scheduling, circumstances and timing, around and regarding the killing of my sister to target and abuse my elderly mother. I seek an end to such. I believe the end to such can start here.

In closing, the Access-A-Ride No Shows and the excessive late cancellation allegations are inaccurate. At 84 years old, my elderly mother should not be confronted with having to mastermind a system to verify timely called in cancellations and no show allegations.

Finally, please make sure this entire situation is not a direct result of and in retaliation to us filing a documented 311 complaint against Access-A-Ride hit men, acting as workers. Please investigate the above noted and linked harassment.

Please note the Access-A-Ride violation allegations are excessive, untrue, and unwarranted. My elderly mother did nothing to warrant this suspension threat. She is being exploited. Please correct this. Thank you for your time.
