RE: CRIMINAL REPORT, REGIONAL KILLERS BOYDEN GRAY AND JONATHAN LIPPMAN DISGUISED ATTEMPTED MURDER OF MY 22 YEAR OLD NEPHEW VIA DEADLY USURPATIONS IN THE MEDICAL FIELD, CRIMINALLY INSANE GENOCIDAL USURPED COORDINATED CRIMINAL MEDICAL ACTS TO INDUCE SEIZURES AND INDUCE HOSPITALIZE MY HEALTHY 22 YEAR OLD INNOCENT NEPHEW VIA CRIMINAL NAME ALIGNED REGIONAL KILLER BOYDEN GRAY UNREGULATED GENOCIDAL AND GENERIC UNVERIFIED PRESCRIPTION MEDICINE TITLED CLONAZAPEM AND UNREGULATED USE OF ENERGY TECHNOLOGY EXPERIMENTATION VIA SATELLITE THAT INFLECTS TORTURE, AND INDUCES AN ATTEMPTED MURDER HOSPITALIZATION AND TO CRIMINALLY ATTEMPT TO CREATE A DISABLED/ MEDICALLY DEPENDENT/UNEMPLOYED/ UNABLE TO WORK YOUNG BLACK MAN. THIS IS A PUBLIC APPEAL AND CRY TO STOP REGIONAL KILLER BOYDEN GRAY AND HIS EUGENIC AND GENOCIDAL REGIONAL KILLINGS TARGETING YOUNG HEALTHY, READY, WILLING AND EQUIPPED TO WORK YOUNG PEOPLE. PLEASE STOP THIS GENOCIDE.

Dear Public Officials:

I write this letter with respect to Regional Killer Boyden Gray's direct name alignments in the disguised attempted murder of my 22 year old nephew via deadly human research genocidal crimes inflicted on him. . These crimes have criminally obstructed his God given life to live free from genocidal human research criminal experimentation embedded in electronic torture crimes. Above all, this letter is written so human research protections can be enforced that stop ongoing, unregulated, criminally insane, genocidal and eugenic coordinated acts that criminally create a medically dependent oppressive young people population. This is a public cry to stop this documented genocide.

Foremost, my nephew is a healthy, handsome, former college attending young man who has no medical history of any diseases or health problems. Recently, he has been tortured by applications of energy technology experimentation via satellite. This means he is being criminally tortured, medically set up, and induced into the hospital by the unregulated use of energy technology utilizing satellites to subject involuntary human beings to unethical and deadly experimentation.

Last year he had some injections. The injection process was corrupted and he was criminally injected with micro chips that advance the energy technology experimentation via satellite. No one is verifying the material purported to be in injections and vaccines. Eugenicists know this and are using this loop whole to micro-chip, infest and kill. They have multifaceted disguised killing genocidal programs that must be shut down.

Currently my healthy, 22 year old, nephew is being electronically tortured and not allowed to work or study. Any time of the day, he can be hit by an electronic weapon, be knocked out, and filled with violent tremors and vibrations. The electronic torture weapons are being utilized to induce violent tremors/vibrations, appearing as febrile/baby seizures. The electronic torture attacks are inevitably criminally forcing him to go to the hospital. The attacks are now violent. He has never had these attacks before and these attacks are not natural or unique. The electronic attacks are deadly, scripted, targeted to young people and name aligned to [Regional Killers Boyden Gray](#) and [Jonathan Lippman](#).

Consequently, I am compelled to write this criminal report detailing the step by step genocidal coordinated acts and crimes inflicted on my healthy nephew. These electronic torture crime weapons are being used on him to create falsified medical records and the electronic torture crimes have been inflicted on him to create need for medication. Because of the continuous electronic remote torturing crimes, my healthy nephew was criminally forced to the doctor and was prescribed the below deadly Regional Killer Boyden Gray name aligned, genocidal medication, titled: **Clonazepam. He was also prescribed some tear drops. He has never had eye and or any health problems. In this matter, the tear drops and the medications were prescribed to virtually kill my nephew via induced seizure. The goal is to hospitalize him and I seek the dismantling of such criminally insane unregulated programming.**

The deadly prescription Clonazepam was criminally given to my nephew while it advances the electronically inflicted muscle spasm and body vibrations my nephew complained of. Please see exhibit 1. The electronic torture and the Clonazepam medication combined are being used as the gateway for inducing seizure and hospitalization. The premeditated induced hospitalization is the criminal gateway for a hospital injection that will criminally render a young adult, like my nephew, sterile and or with viruses that will deform and defect his future babies because this is what criminally insane unregulated eugenicists do.

This is what genocide is all about, obstructing one's God given right to reproduce healthy children and multiply. This is why the criminally insane eugenicists are creating falsified medical records on my nephew because the long term plan is to kill his seed and they want him hospitalized and we want the crimes stopped! These crimes must be stopped. This is a deadly, criminally insane, genocidal, conspiracy to murder, coordinated plan.

This is a public cry for this scripted genocide program to be stopped. For purposes of clarification, please let me explain how these genocide crimes work. The global plan to inject children and youth is to plant microchips. Once the children and youth are chipped, the eugenicists control and torture children via applications of remote energy technology experimentation. There is a need for regulation of energy technology experimentation via satellite. There is a need for criminal penalties enforcement on people who inject microchips on people without consent and unbeknownst to the victim. Criminal remote energy technology experimentation is another phrase for electronic torture. Criminal remote energy technology experimentations are being used to stop people from studying and working. They are being used to medically set up healthy people and criminally create a disabled and oppressed population. These weapons are being used on young people of color, particularly boys, at a disproportionate rate. Above all, electronic torture is being used to medically set up innocent people. My nephew is one.

Criminal remote energy technology experimentation is being criminally used on innocent people to force contact with a doctor regarding a premeditated medical phenomenon. Electronic torture weapons are used to inflict tremors, violent body vibrations, taserings, etc.... These symptoms are considered medical phenomena. This electronic torture induced medical phenomenon is used to create false mental records and provides the gateway for deadly medical prescription dissemination as done to my nephew. My nephew is being tortured and victimized by unregulated generic medicine that enhances the electronic torture illnesses. The torture is unbearable and as such I am documenting it and appealing for help. The problem stems with unregulated and unsupervised energy technology experimentation via satellite and use of the injection process to criminally micro chip.

It is my contention that many other young people are targeted for this criminal induced suicide genocidal program. Consequently, I write this letter seeking an end to the blind eye to this criminal Targeted Individual killing program.

My nephew is being criminally electronically tortured, was forced to drop out of school because of these crimes, is not being allowed to work, is criminally being forced to disability, has been given killer genocidal drugs, has this eugenic hit on him trying to criminally create a medically dependent, mental ill or suicidal person, that is not my nephew. Above all these genocidal crimes are implemented to stop him from having a family. These genocidal crimes are premised off of criminal coordinated acts. These criminal genocidal coordinated acts include:

- ✓ **Direct killing and actions causing death,:** My nephew was given deadly genocidal medication titled **Clonazepam**, when and while the medication is known to cause and accelerate the very symptoms the electronic torture inflicts, induced seizures, violent body vibrations, and torturous muscle spasms. Regional Killer Boyden Gray's name aligned **Clonazepam** medication enjoinder in my nephew's life, coupled with the drug's history of induced seizures, exemplifies one of the genocidal coordinated acts that program and cause death.
- ✓ **Causing serious bodily or mental harm includes, inflicting trauma on members of the group through widespread torture:** Torture by applications of energy technology experimentation via satellite, is the clearest form of mental harm and this criminal deadly experimentation is listed as number one in advancing induced suicides.
- ✓ **Prevention of births includes involuntary sterilization, forced abortion, prohibition of marriage, and long-term separation of men and women intended to prevent procreation. The use of electronic torture to induce illness that require medication and the use of this process to medically set up one for a genocidal prescription such as Clonazepam, which is known for erectile disorder and inhibition of orgasm, as well as induced seizures, each exemplify, complicity in genocide coordinated acts indicative of prevention of births genocidal planning.**
- ✓ **Psychological oppression or other methods of coercion. Electronic torture is premised off of and inflicts psychological oppression and other deadly and torturous crimes.**
- ✓ **Genocidal acts need not kill or cause the death of members of a group. Causing serious bodily or mental harm, prevention of births and transfer of children are acts of genocide when committed as part of a policy to destroy a group's existence.**

Young people are being targeted for micro chipped injections globally as part of these sick depopulation, infestation and genocide plans. Injections are being used to criminally implant microchips in people to allow the criminals to work remotely, to criminally control and disable populations of people, from working to criminally create a disabled and medically dependent oppressed population.

Criminal remote energy technology experimentation, specifically electronic torture inflictions on innocent groups of people and the coordinated medical acts that come with it, including the warrantless dissemination of deadly mental illness and induced seizure generic drugs, exemplify complicity in genocide as described in [international law](#):

In this matter, my nephew has been and is being electronically tortured in an attempt to create symptoms of an induced seizure. He has never had seizures, tremors, or vibrations before. The electronic torturing must be stopped. Please see regional Killer Boyden Gray's below history on criminally inflicting induced seizures on children.

The eugenicists running this genocide program are trying to criminally induce my nephew into the hospital. They are torturing him with electronic weapons. They are inflicting on him torturous muscle spasms, tremors, violent body vibrations, and have added a tear and eye problem. He has never had these conditions before. They are using criminal energy technology experimentation via satellites to torture him.

In addition, they have given him the above noted criminal medication and some tear drops specifically designed to advance a criminal premeditated seizure; he has never had in his life. Please let me be clear. The electronic weapons were criminally used to induce the appearance of seizure symptoms on my nephew and were used to induce an eye problem he never had. 

When a 5-micromillimeter microchip (the diameter of a strand of hair is 50 micromillimeters) is

placed **into optical nerve of the eye**, it draws neuroimpulses from the brain that embody the experiences, smells, sights, and voice of the implanted person. 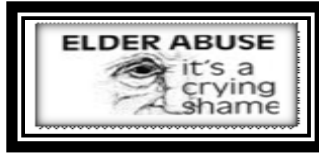
